The mare owner's commitments:

- Ensures that the mare is fully healthy and has not been ill or in contact with infected horses at least three weeks before arrival (this also applies to ringworm or other type of fungus).
- A mare that has previously been with another stallion, and did not become pregnant, should be examined by the veterinarian prior to arrival to avoid spreading of any disease or infection.
- Copy of horse passport, vaccination certificate is submitted to the stallion holder.
- Information about any peculiarities of the mare , such as eczema, elusive etc., and a signed copy of this contract must be sent to the stallion holder upon booking.
- Has the mare previously not been pregnant, desorbed or had a stillborn foal a vaginal bacterium sample must be taken of the mare and certificates must be shown for the stallion holder.
- Mare and foal older than 8 weeks, must be wormed before arrival
- The mare should be unshod and the hooves newly trimmed, and the mare must be vaccinated (tetanus and flu)
- We wish the owner to take an ultrasound to see where the mare is in the heat, to protect both mare and stallion for possible injury.
- For mares from Denmark / Germany that are previously covered, CEM test is required.

The owner is aware that:

- The horse owner leaves the horse at his own risk
- The stallion holder is entitled to keep the mare until full payment has been received.

Stallion holder's commitments:

- Take care of the horses that have been left for cover, in the best possible way.
- Immediately inform the mare owner of signs of disease in the mare or foal.
- Contact the veterinarian to perform treatment, if necessary for the horse's well, even if the owner of the mare cannot be reached. The owner then pays the veterinary costs incurred.
- If signs of itching in mane and tail occurs, the mare owner should be notified immediately

Generally

- The stallion owner has the right to detain mare and possibly foal until full payment has been made (exercise of right of retention) and to cover costs.
- The stallion owner has the right to sell mare and possibly foal, upon request by the court or other legal authority in favor of the stallion owner.
- Signing of this agreement means that the mare owner undertakes to leave Follow-up report (result –date of birth, mare or stallionfoal, not pregnant, or stillborn foal) to the stallion owner as soon as results are known, but no later than 1 October 2018.
- If you want to visit your horse during the stay with us, please contact us in advance?
- Due to possibility of infections, we do not accept any horse that comes with a “ large” transport.

Unless otherwise stated, mares are kept in flock or alone, around the clock with daily supervision.

Price list

Booking fee: 2 000 SEK + VAT (2500 SEK) (offset when you pay for covering)

Covering fee: 9,000 SEK + VAT (11,500 SEK) NOTE! Billed on the first cover date. Always done.

21-day pregnant fee: 10,000 SEK + VAT (12,500 SEK)

Discount for 1st class mares 2000 SEK + VAT (2500 SEK)

Sif's mare fee: 250 SEK

All the above costs are billed by stallion owner: Prästgårdens Islandshästar HB

Other costs are invoiced separately by the stallion holder.

Service fee: 100 SEK per day + VAT(125 SEK)

Extra care fee of mare with eczema / cover: 20 SEK + VAT / day (25 :-)

Other fees: Ultrasound / veterinary costs, transporting or something not mentioned above
